General terms and conditions

Registration

We confirm your registration by e-mail.

VAT

All amounts mentioned are in Euro and exclusive of the statutory value added tax of currently 19 %.

Payment modalities

The invoice amount is due for payment within 14 days after receipt of the invoice without deduction.

Cancellation conditions

- Cancellations up to 21 days (3 weeks) before the start of the event: free of charge
- Cancellations between 20 to 8 days (between 3 and 1 week) before the start of the event: 50% of the participation fee
- Cancellations 7 days or more (1 week to 0 days) before the start of the event: 100% of the participation fee

Non-attendance at the event does not release the participant from the obligation to pay the fee. The provision of a substitute participant in compliance with the respective selection criteria is possible. The cancellation fee will not be charged if a substitute is named. This re-registration also requires the written form and is to be made by the original registrant. The original registrant remains obligated to pay the participation fee to the organizer until the change has been made. Reschedule / postpone participation to a later date
